INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The National Irrigation Administration (NIA) Region 5, Panganiban Drive, Naga City, , invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) , to apply for eligibility and if found eligible, to bid for the hereunder contract:

Prospective bidders should possess a valid PCAB license applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipments available for the prosecution of the contract. They must own the minimum required equipments of **two units water pump (4"Ø), one unit dump truck and one unit concrete mixer**. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of bid.

All particulars relative to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R. A. 9184 and its Implementing Rules and Regulations (IRR).

The BAC will issue to prospective bidders Eligibility Forms at the Office of the Chairperson, NIA, Region 5, Panganiban Drive, Naga City, upon their submission of a LOI, and upon payment of non-refundable amount of ₱500.00 for registration fee and various eligibility forms to the NIA Regional Office Cashier. Prospective bidders shall submit the Eligibility Requirements to the BAC at the said address. They may also obtain the results of the Eligibility Check by the BAC at the same address.

The BAC will issue Bidding Documents only to bidders declared by the BAC to be eligible for the bidding upon payment of a non-refundable amount of ₱ 1,628.00 to the NIA Regional Office Cashier.

Bids shall be valid for a period of 120 days after Bid opening and must be accompanied by a bid security in the amount of ₱ 16,280.00 in form of cash/certified check/manager's check or bank guarantee equivalent to 1.5% of the ABC, or form of surety bond equivalent to 2.5% of the ABC, and shall be included in envelop one, to be submitted during the public bidding on **Aug. 11, 2008 at 9:00 AM**, at which time the Bids will be opened in the presence of bidders who wish to attend.

The NIA Regional Office No. 5, BAC, Naga City, reserves the right to reject any or all bids, waive any defect or formality, assume no obligation whatsoever to compensate indemnity to the contractor/bidder for any expenses that they may incur in the preparation of bid and to accept the lowest evaluated, responsive and complying bid.
