INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The NIA Region I, through its Bids and Awards Committee (BAC) invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to apply for eligibility and if found eligible to bid for the hereunder contract funded under FUND 101.

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the prosecution for the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check./Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the provisions of RA 9184 and its implementing Rules and Regulation (IRR).

The BAC will issue to prospective bidders Eligibility Forms at NIA-RIO, Urdaneta City upon their submission of the LOI, and upon their payment of non-refundable amount of Five Hundred Pesos (P500.00) to the NIA-RIO Cashier. Prospective bidders shall submit the Eligibility Requirements to the BAC at the said address. They may also obtain the result of the Eligibility Check by the BAC at the same address.

The BAC will issue Bidding Documents only to bidders declared by the BAC to be eligible for the bidding upon payment of non refundable amount of **THREE THOUSAND PESOS (Php 3,000.00)** to the NIA Cashier.
